## **Appointment Policies**

One <u>consultation</u> visit is free of charge. A 24 hour notice is required to reschedule a consultation appointment If less than a 24 hour notice is given, or if an appointment is a "no-show", a \$50 cash prepaid deposit is required to schedule another consultation. There is a \$25 fee for correction and removal consultations.

To reserve an appointment for a procedure, a \$50 non-refundable deposit is required. Payment methods accepted are check, and cash or CC card. You can pay with a credit card on my website. The deposit will be applied toward the cost of the procedure.

If an appointment must be rescheduled, a **48-hour notice is required no exceptions.** With 48 hours or more notice, the \$50 deposit will be applied toward the rescheduled appointment. If a procedure appointment is canceled, changed or is a "no-show" with less than 48 hours notice, the deposit will neither be refunded nor reapplied.

The first session of the process for **new procedures** is the <u>Saturation</u> visit. As the name implies, the Saturation visit accomplishes the basic design and color saturation. The skin is an imperfect canvas. A touch-up is an appointment that is needed most of the time to complete the procedure process. The touch-up appointment is a fine-tuning session to make any adjustments that may be needed or desired to the shape, fullness, and color and to go over any areas that may not have taken well the first time. Many times the color implanted is not perfect the first time when healed that is why permanent makeup is almost always a two or more step process. My personal experience is that many will require one touch-up, whereas some will require a second touch-up appointment depending on the procedure or desired outcome results. It is my opinion everyone should utilize that touch-up appointment, even if everything appears perfect. A second coat will give your procedure depth and longer life. Everything looks better and lasts longer with a second coat so will your eyebrows, eyeliner, and lips

There is a minimal charge for the Touch up visit as long as it is *completed within* **90** *days* of the *previous* visit. This charge is determined by the type of procedure. After that amount of time it may be considered a color refresher and priced accordingly. If you need to cancel or re-schedule your appointment a 48-hour notice is required. If less than a 48-hour notice is given or if an appointment is a "no show" then a \$50 pre-paid deposit is required to reschedule the appointment and you will need to pay the touch up fee along with the deposit.

All procedures for corrections and removals are priced "per-visit".

Cosmetic Tattooing requires maintenance as all color fades. The amount of fading depends on several variables including medications and topical treatments, and certain skin conditions, but is primarily due to sun (ultra-violet) exposure; therefore measures should be taken to protect your permanent cosmetics from the sun. (Sunglasses, billed caps, visors and sunscreen)
